2. HAZARDS IDENTIFICATION

Main hazards: Irritating to eyes, respiratory system and skin.

3. COMPOSITION / INFORMATION ON INGREDIENTS

Hazardous ingredients: EDTA DISODIUM SALT,DIHYDRATE >90%

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.
Eye contact: There may be irritation and redness. The eyes may water profusely.
Ingestion: There may be soreness and redness of the mouth and throat.
Inhalation: There may be irritation of the throat with a feeling of tightness in the chest. Exposure may cause coughing or wheezing.

4. FIRST AID MEASURES (ACTION)

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

Extinguishing media: Suitable extinguishing media for the surrounding fire should be used. Carbon dioxide. Dry chemical powder. foam

Protection of fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

6. ACCIDENTAL RELEASE MEASURES

Environmental precautions: Do not discharge into drains or rivers.

Clean-up procedures: Transfer to a closable, labelled salvage container for disposal by an appropriate method.

7. HANDLING AND STORAGE

Handling requirements: Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Do not handle in a confined space. Avoid the formation or spread of dust in the air. Only use in fume hood.

Storage conditions: Store in cool, well ventilated area. Keep container tightly closed.

Suitable packaging: Must only be kept in original packaging.
